Please fill out this form if you are a low volume or residential consumer and want to change the Regulated Price Plan (RPP) structure that applies to the Electricity supplied by London Hydro.

There are three rate options: **Time-of-Use** (TOU), **Ultra-Low Overnight** (ULO) and **Tiered** (TIER) pricing. Under **TOU and ULO** pricing, the price you pay for electricity depends on when you use it. Under **Tiered** pricing, you can use a certain amount of electricity at a lower price, and once that limit (tier) is exceeded, a higher price applies. The billing number, name, and service address must be entered exactly as it appears on your electricity bill. (If you have multiple accounts with London Hydro that you wish to change, separate forms must be completed for each account.)

³ An eligible residential unit means a unit that is a self-contained set of rooms located in a building or structure, contains kitchen and bathroom facilities that are intended for the use of the unit only, and is used or intended for use as a residential premises - please see the regulation filed under 156/15 of the Ontario Energy Board Act, 1998, and Ontario Reg 493/01 for more details.
