



PRICE PLAN ELECTION FORM
For General Service, Greater than 50 kW

Pursuant to the Regulation filed under s. 79.4(1) (a) of the Ontario Energy Board Act, 1998, and Ontario Reg. 95/05, the Ontario Government has identified the criteria to determine your eligibility to receive the fixed commodity price (Regulated Price Plan) currently in place in Ontario.

As an eligible Regulated Price Plan (RPP) customer¹ your default price plan will be Time-of Use (TOU) but you have the option to choose Tiered pricing. Under Time-of-Use pricing, the price you pay for electricity depends on when you use it. Under Tiered pricing, you can use a certain amount of electricity each month at a lower price, and once that limit (tier) is exceeded, a higher price applies. Alternatively, a customer that is eligible for the Regulated Price Plan (RPP) may elect to opt out of the plan and have their account be placed on SPOT prices (Hourly Ontario Energy Price)².

Upon receipt of a request to change pricing options, the distributor shall charge the consumer in accordance with section 3.2.2 for electricity consumed after an actual read of the consumer's meter by the distributor is obtained.
