



## REGULATED PRICE PLAN DECLARATION of ELIGIBILITY For General Service, Greater than 50 kW

To elect the Regulated Price Plan (RPP) you must first declare your eligibility.

Pursuant to the Regulation filed under s. 79.4(1) (a) of the Ontario Energy Board Act, 1998, and Ontario Reg. 95/05, the Ontario Government has identified the criteria to determine your eligibility to receive the fixed commodity price (Regulated Price Plan) currently in place in Ontario.

There are three options: **Time-of-Use (TOU)**, **Ultra-Low Overnight (ULO)** and **Tiered (TIER) pricing**. Under **TOU and ULO** pricing, the price you pay for electricity depends on when you use it. Under **Tiered** pricing, you can use a certain amount of electricity each month at a lower price, and once that limit (tier) is exceeded, a higher price applies. This form is used to notify London Hydro Inc. of a customer's eligibility for the Regulated Price Plan and the preferred pricing option according to the regulation.

### **Step 1 - Determine if the Account Qualifies**

#### **FARM Eligibility**

- A consumer carries on a farming business within the meaning of the Farm Registration and Farm Organizations Funding Act, 1993 and the consumer either holds a valid registration number assigned under the farm registration and Farm Organizations Fund Act, 1993 or the consumers obligation to file a farming business registration form was waived pursuant to an order made under subsection 22 (6) of the Act , and the consumer is not otherwise eligible for treatment under clause 79.16 (1) (b) of the Act with respect to its farming business pursuant to a regulation made under the Act). #### **RESIDENTIAL Eligibility**

- The account relates to a property as defined in the Condominium Act, 1998.
  - The account relates to a residential complex as defined in the Residential Tenancies Act, 2006.
- OR
- The account relates to a property that includes one or more dwellings and that is owned or leased by a cooperative as defined in the Co-operative Corporations Act.

AND

- The associated meter services a common area of the complex.

OR

- The associated meter services multiple residential units<sup>1</sup> (bulk metered).
